Disclaimer and Privacy Policy

A. General Legal Disclaimer

B. The Types of Information Owner Collects About Visitor

When a Visitor enters and browses the Website, the Owner may collect two different types of information about the Visitor: information the Visitor provides to the Owner, and information the Owner collects through technology.

1. Information Any Visitor Provides to the Owner

In order to obtain access to certain information or materials provided via the Website, a Visitor may have to provide information that the Owner collects and stores in a way that allows the Owner to relate it to each Visitor personally, including but not limited to Visitor's name, e-mail address, mailing address, phone number, facsimile number and the type of occupation the Visitor is (e.g., individual, analyst, broker). Such personally identifiable information may be collected and a record of all communications with the Visitor may be retained.

2. Information that may be Collected Through Technology

Certain information (For example, Visitor's IP address) may be collected directly by the Website. At times, the Owner may also use IP addresses to collect information regarding the frequency with which Visitors browse various parts of the Website.

The Website may also use other technical methods to track and analyze the traffic patterns on the Website, such as the frequency with which the Visitors visit various parts of the Website. These technical methods may involve the transmission of information either directly to the Owner or to another party authorized by the Owner to collect information on Owner's behalf. The Owner

may also use these technical methods in HTML e-mails that the Owner sends to the Website Visitor to determine whether such Visitors have opened those e-mails and/or clicked on links in those e-mails. The Owner may collect the information from use of these technical methods in a form that is personally identifiable.

During some visits the Website may use software tools such as JavaScript to measure and collect session information, including page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse overs), and methods used to browse away from the page. The Owner may use this information to measure Site activity, to develop ideas for improving the Website and for any other purpose to the extent permitted by applicable law.

3. Use of Personally Identifiable Information

The Owner does not disclose any non-public personally identifiable information about its Website Visitors to any nonaffiliated third party, except as set forth below.

The Owner may use or disclose certain personally identifiable information collected at the Website as part of Owner's normal business operations, or to send the Visitor administrative communications for example about the interactions with the Owner or about features of the Website, including any future changes to this Privacy Policy. Such information may be stored and shared with the affiliates as well and may be used for marketing, research and other business purposes but the Owner will not sell this information or disclose it to third parties except to (A) service providers to improve functions of the Website and our business functions' or to any person who may acquire the Owner or its businesses; and (B) as may be required under law, regulation, legal process, subpoena, document request or governmental request.
